Criteria for Interim Reclamation

The area certified to be 'interim' reclaimed shall meet the following criteria:

1. The area is at least 1 acre in size:
2. The area has been allowed to revegetate for at least 6 months.

If 'interim' reclamation is certified, ECWRPC will remove the acreage from the annual fee calculation during the next calendar year.

The applicant may also submit revised financial assurance estimates at the time of request. ECWRPC will review the estimates against the reclamation plan and may reduce, as appropriate, the amount of financial assurance required.

Criteria for Final Reclamation

The area certified for 'final' reclamation shall meet the following criteria:

1. The area is at least 1 acre in size:
2. The area has been allowed to revegetate for at least 12 months

If 'final' reclamation is certified, ECWRPC will complete a 'certificate of completion' (COC) and the financial assurance will be released back to the applicant.
